South Coast AQMD Issues Ozone Advisory Due to Heat Wave

Valid until Thursday 8:00 p.m.

Forecasted Air Quality Impacts

• A multi-day extreme ozone (smog) event is expected due to the heat wave affecting the region.

- The National Weather Service has issued Heat Advisories and Extreme Heat Warnings. Visit <u>https://www.weather.gov/sgx/</u> and <u>https://www.weather.gov/lox/</u> for more information.
- Air Quality Index (AQI) will likely reach **Unhealthy for Sensitive Groups** or higher levels in inland parts of the South Coast Air Basin including Lake Elsinore, Corona, Hemet, and Pasadena as well as in the Coachella Valley.
- AQI will likely reach **Unhealthy** or higher in the Santa Clarita Valley, portions of the San Gabriel Valley, the San Bernardino Valley, and portions of the San Bernardino Mountains from Tuesday through Thursday.
- Ozone levels are expected to be lower in coastal areas.
- South Coast AQMD will issue an update if ozone levels are predicted to remain high after Thursday.

Detailed Forecast

Daytime	Each day, AQI levels will increase after sunrise, peak in the mid- afternoon, and then decrease. AQI is predicted to reach the Unhealthy category in large portions of the region.
Early morning and overnight	AQI is predicted to be in the Good to Moderate categories overnight and in the early morning hours each day.

South Coast AQMD will issue an update if additional information becomes available.

During periods of poor air quality due to ozone pollution:

- Check air quality levels and limit outdoor activities as necessary. See <u>health recommendations</u> for each AQI level.
- Limit the use of gasoline powered lawn and garden equipment until evening hours.
- Conserve electricity and set your air conditioner at a higher temperature.
- Try to delay trips to the gas station and the use of household chemicals until the evening.
